MEMORANDUM CIRCULAR

**AMENDING PNP MEMORANDUM CIRCULAR NO. 2021-107 ENTITLED
"REVISED POLICIES AND PROCEDURES ON THE ASSIGNMENT,
REASSIGNMENT, PLACEMENT, AND DETAIL OF SECOND LEVEL UNIFORMED
PERSONNEL"**

1. REFERENCES:

- a. Section 26 of Republic Act No. 6975 dated December 13, 1990 entitled, "*An Act Establishing the Philippine National Police Under a Reorganized Department of the Interior and Local Government, and for other Purpose*"; and
- b. PNP Memorandum Circular (MC) No. 2021-107 dated July 27, 2021 entitled, "*Revised Policies and Procedures on the Assignment, Reassignment, Placement and Detail of Second (2nd) Level Uniformed Personnel*".

2. PURPOSE AND SCOPE:

This PNP MC is an amendment to the provision of the PNP MC No. 2021-107 modifying the tenure in service of newly promoted Second Level Uniformed Personnel assigned to SAF, PNPA, NPTI, and PNPTS prior to reassignment to other PNP offices/units, reckoned from the effectivity of their promotion.

3. AMENDMENT:

The following provision of the PNP MC No. 2021-107 is hereby amended to read as follows:

xxx

6. GUIDELINES:

a. General Guidelines

9. Second Level Uniformed Personnel who are newly promoted shall be eligible for reassignment after six months from the effectivity of their promotion, except those assigned to SAF, PNPA, NPTI, and PNPTS who shall render a minimum of two years in the offices/units where they were promoted, unless the service warrants.

4. REPEALING CLAUSE:

All existing PNP directives and other issuances which are contrary to or inconsistent with the provisions of this MC are hereby rescinded or modified accordingly.

5. EFFECTIVITY:

This MC shall take effect after 15 days from filing a copy thereof at the University of the Philippines Law Center in consonance with Section 3, Chapter 2, Book VII of Executive Order No. 292, otherwise known as the "Revised Administrative Code of 1987", as amended.
