**AMENDING PARAGRAPH 3.B OF PNP MEMORANDUM CIRCULAR
 NO. 2023-044 DATED JULY 3, 2023 AND PARAGRAPH 7.A.9 OF
 PNP MC NO. 2022-015 DATED JANUARY 27, 2022**

1. REFERENCES:

- a. PNP Memorandum Circular (MC) No. 2023-044 dated July 3, 2023 entitled, "Amending Certain Provisions of the Certificate of Accreditation under Item 8 of PNP Memorandum Circular No. 2022-015";
- b. PNP MC No. 2022-015 dated January 27, 2022 entitled, "Unified Policies, Guidelines, and Procedures in the Implementation of the PNP Automatic Salary and Pension Deduction Scheme (ASPDS)"; and
- c. PNP MC No. 2016-065 dated October 19, 2016 entitled, "Revised Policy on Absence Without Official Leave and Dropping from Rolls".

2. PURPOSE:

This PNP MC amends paragraph 7.a.9 of PNP MC No. 2022-015 to increase the limitation of deduction codes for each Financial Institution (FI) in the PNP ASPDS and paragraph 3.b of PNP MC 2023-044 to change the number of the cited PNP MC.

3. AMENDMENTS:

- a. Paragraph 7 (Procedures) sub-paragraph a.9 (Accreditation of FIs) of PNP MC No. 2022-015 shall be read as follows:

xxx

"9. The PNPFS shall allot twenty-five (25) deduction codes for each FIs in the SDLIS and twenty-five (25) deduction codes for each NSSLA and cooperatives in the PDLIS based on CAAD Resolution approved by the Chief, PNP."

b. Paragraph 3.b (Amendments) of PNP MC 2023-044 shall be read as follows:

XXX

"8. The PNP may, under justifiable reasons specified, pursuant to existing laws, regulations, issuances and circulars, unilaterally stop, reduce or understate the deductions even without the express consent of the Fls."

4. EFFECTIVITY:

This MC shall take effect after 15 days from filing a copy hereof at the University of the Philippines Law Center in consonance with Sections 3, Chapter 2 of Book VII of Executive Order No. 292 otherwise known as the "Revised Administrative Code of 1987", as amended.
